Image resolution: 300 dpi. Do not use any compression scheme on the graphics (JPEG, LZW).

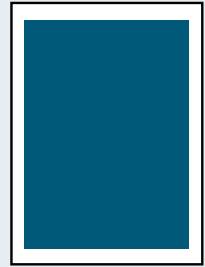
Include all placed graphics. Do not embed images in the file. Do not trap files—if necessary, this will be done in our preflighting. Color images should be saved in CMYK format.

Company logo requested in high-resolution electronic format for ASA website.

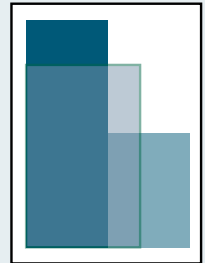
